

Terms and Conditions for the Hamptons Big Night Out for CRUK Prize Draw

1. The **Hamptons Big Night Out for CRUK** Prize Draw (“the Prize Draw”) is offered by Hamptons International, a trading name of Countrywide Estate Agents, whose registered address is at **Greenwood House, 1st Floor, 91-99 New London Road, Chelmsford, Essex, CM2 0PP** (“the Promoter”).
2. Entry into the Prize Draw shall open on 17th May 2019 at 09:00 hrs (BST) (“Start Time”) and will close at 21:00 hrs (BST) on 17th May 2019 (“Closing Date”). Entries received outside of these dates and times will not be valid but any donation made on entry will still be processed.
3. Entry into the Prize Draw is open to eligible entrants only. An eligible entrant is one who is a UK resident who is aged 18 years or over excluding employees of the Promoter and any persons who are connected in any way to this Prize Draw (“Entrant”). Proof of age and identity may be required.
4. Entries are made by either:
 - a) purchasing a ticket at a cost of £5 per ticket (1 ticket per entry) or 5 tickets for £20 (5 entries) from Hamptons International Tunbridge Wells between the Start Time and Closing Date, or at the Hamptons Big Night Out event on 17th May 2019, until 9pm (“Entry Route A”);
 - or
 - b) providing your contact details (name, telephone number and email address) in writing to a representative of the Promoter at Hamptons International Tunbridge Wells between the Start Time and Closing Date, or at the Hamptons Big Night Out on 17th May 2019 until 9pm, indicating your desire to enter the Prize Draw and the number of entries you wish to make (“Entry Route B”). You will receive a ticket containing unique entry number. This is your free entry route and you will be entered into the Prize Draw once for every entry you make.
5. The Promoter does not accept any responsibility for entries that are lost, late or incomplete or have not been received due to any error beyond the Promoter’s reasonable control. Proof of sending is not proof of receipt.
6. Entrants will receive a ticket containing a number and their name which will be entered into the Prize Draw whereby the first 14 names drawn at random from all eligible entries received will be the winning entries.
7. One prize per winning entry. The draw will take place at the event on the 17th May 2019 (“draw date”). There are 14 prizes in total. For full details of the prizes, please contact The Promoter by email at: **greylings@hamptons-int.com**
8. Each winner of the Prize Draw will be notified using the contact details they provided within 7 days of the draw date. Winners will need to respond to The Promoter with their postal address for delivery of the prize.

9. If a winner does not reply within 7 days of first being notified by the Promoter, he or she will forfeit the prize and another winner will be selected from the remaining eligible entries in accordance with the above process until a winner is selected and can be contacted.
10. The Promoter will endeavour to send the prizes to the winners within 30 days of the draw date. Prizes will be sent by post and The Promoter accepts no liability for any lost or delayed prizes.
11. The prizes are non-transferable and not exchangeable for cash or any other prize and if any prize is not available, The Promoter reserves the right to offer an alternative prize of a similar value.
12. The prizes are being supplied by external donators/suppliers ("Donors"). If you encounter any problems with the enjoyment of a prize, please contact the Donor in the first instance. The Donor's terms and conditions will apply to the prize. Please contact the Donor for a copy of the Donor's terms and conditions and only accept a prize if you are happy to accept the Donor's terms and conditions. The Promoter gives no guarantee or warranty regarding the prizes.
13. The prizes will also be subject to Donors' exclusions and additional eligibility requirements. For example, prizes may need to be enjoyed on specific dates, winners may need a valid passport/driving licence etc. Please contact the Donor of the prize for information on the eligibility requirements and only accept a prize if you are happy to accept the Donor's exclusions and eligibility requirements.
14. In the event of unforeseen circumstances, The Promoter reserves the right to amend or withdraw the Prize Draw at any time.
